Introduction

The Sexual Health Centre is a Not for Profit, Voluntary Sector/Non-Governmental Organisation (NGO). The centre is situated at 16 Peters Street in Cork City.

Tender Outline

The Sexual Health Centre is seeking tenders from suitably qualified individuals or organisations to design and deliver a mural for the End HIV Stigma Project. 'End HIV Stigma' is a creative outreach project that aims to reduce stigma about HIV in Cork by bringing the topic into public conversation and public space, educating the general public about the progress in HIV care, celebrating how far we've come and acknowledging how far we have yet to go.

This project will be delivered via four work packages: a series of workshops, a publication, a mural, and a public talk, and will centre the lived experiences of people living with HIV in Cork. It will be delivered by the Sexual Health Centre, in collaboration with the selected artist, and will be supported by ACT UP Cork, Positive Cork, Cork HIV Treatment Clinic, Cork City Council and is funded by the Health Service Executive.

The current tender focuses on securing an artist to deliver the mural by November 30th, 2021 so that it can be officially launched for World AIDS Day on December 1st, 2021. The successful tenderer will be required to attend an online workshop scheduled for Saturday, October 2nd with individuals living with HIV so that they can hear of their lived experiences. The information gathered at this workshop will inform the design of the mural. The successful tenderer will also be required to participate in a public talk as a panellist on World AIDS Day (December 1st), discussing their participation in the End HIV Stigma project.

Fee Proposal

The fee proposal submitted, shall be in Euro (€) and inclusive of VAT and all expenses. A breakdown of total costs should be provided. The budget for this contract is a maximum of €4,000 inclusive of all costs, including artist fee.

The Mural

The Sexual Health Centre is currently in discussion with Cork City Council about the location of the mural. It is anticipated that the mural will be located on a single-storey wall. Possible locations under consideration are the wooden hoarding surrounding Grattan House on Grattan Street, the side wall of Paul Street Shopping Centre Car Park on St. Paul's Avenue, or the gable of 9 Grenville Place (on Francis Street).

Tax Clearance

The successful Tenderer must be in possession of a valid tax clearance certificate for the duration of the contract. Such a valid tax clearance certificate from the Irish Revenue Commissioners must be produced by a successful Tenderer before execution of the contract. A valid tax clearance certificate means a tax clearance certificate issued by the Irish Revenue Commissioners, and Tenderers not resident in Ireland must make application to the Irish Revenue Commissioners for such a certificate if their tender is to be considered.

Insurance

The successful Tenderer must produce valid public liability insurance.

Tax Clearance

The successful Tenderer must be in possession of a valid tax clearance certificate for the duration of the contract. A Tenderer shall be excluded who:

- is the subject of proceedings for declaration of bankruptcy or insolvency, for an order for compulsory winding up or a court liquidation, or who has a liquidator or receiver appointed over its assets, or for composition with creditors or any other similar proceedings;
- has been convicted of an offence concerning their professional conduct;
- has not fulfilled obligations relating to the payment of social security contributions;
- has not fulfilled obligations relating to the payment of taxes. False or Misleading Information Tenderers who intentionally or carelessly supply false or misleading information will be disqualified from this Tendering Procedure on the discovery of such information.

Compliance with Law Tenderers should be able to provide on demand evidence of compliance with all laws applicable to the provision of the services which are the subject of the Invitation to Tender, and in particular should be able to produce evidence that they have particular regard for statutory terms relating to minimum pay and any legally binding or sectoral agreements if applicable.

Termination

The contract shall contain provisions reserving to the Sexual Health Centre the right to terminate any contract awarded if it is not satisfied with the performance by the successful Tenderer of the contract. The satisfaction or dissatisfaction of the Sexual Health Centre shall be evaluated in the context of the Tenderers proposal set out in this document.
